

Will Preparation Service Out-Of-Network Flyer

Will Preparation Service¹ participants have the option to retain an attorney who does not participate in Hyatt Legal Plans' network of plan attorneys, and receive reimbursement for the preparation of wills, living wills and powers of attorney up to a set dollar limit, detailed below.

To take advantage of the reimbursement feature, participants simply call the Hyatt Legal Plans' toll-free telephone number below to request a case number and the fee reimbursement claim form. Then, the participant must fill out and sign this claim form, and return it with a copy of the attorney's final bill to Hyatt Legal Plans. Participants will be promptly reimbursed by check according to the schedule below.*

Employees may select any attorney to provide Will Preparation Services. However, we recommend that they discuss the associated fees with attorneys in advance. If they select an attorney whose fees exceed these amounts, employees will be responsible to pay for the excess. The Will Preparation Service covers attorneys' fees only. It does not cover other costs such as filing fees.
